

BijenkorfXShapeways Contest Terms & Conditions.

- 1. Eligibility. This giveaway is operated by Shapeways. It is open to individuals in the Netherlands over 13 years of age at the time of entry who live in a jurisdiction that does not prohibit this contest. Employees, officers, and directors of Shapeways and their immediate family are not eligible to enter. Individuals may enter more than one entry into the drawing but may not do so by way of automated means. By entering this daily drawing, you agree to be bound by these Rules.
